## **Supplements to Application for Admission**

### **Data Protection Article**

1. With the admission of the member the Europäische Autorenkreis für Film und Video – EUROFILMER (EAK) gathers data of the member. This includes especially data serving the administration and purpose of the club, data for film enrollment, competitions, awards, functions within the EAK and honours.

Other information about members and information about non-members are principally only used and processed by the EAK, if they are useful for promotion of the purpose of the club and there are no indications of interests of the person concerned, which are worth being protected and are contradictory to processing or being used.

2. With his admittance the member declares his/her agreement that personal data related to membership are compiled, processed and used for the club in due consideration of the standards of the German Federal Data Protection Act (BDSG). Without this agreement membership cannot be accepted.
3. Administration of members is performed within an internet-protected program software system.
4. At any time each individual member can raise an objection to the board of the club concerning the publication of his personal data or withdraw his granted agreement to the publication. In case of objection or withdrawal, future publications about his person will then be ceased and personal data of the revoking member will be deleted on the home page of the EAK.
5. For participation in competitions of the EAK approval for publication is compulsory and a precondition.
6. The board of the club points out, that adequate technical measures have been taken to ensure data protection. Complete data protection cannot be guaranteed.
